#### **Preamble**

Nalbari College, Nalbari is one of the premier higher educational institutions in Assam. The institution is established in pre-independent India on 4th July 1945. From its establishment onwards, the college has taken a pioneering role in shaping and promoting higher education in the entire lower Brahmaputra valley. This is one of the premier college that consistently demonstrated excellence in academic and research pursuits.

The New Digital Computer is a well-known computer institution and press located in Nalbari District, Assam. The institution is widely recognized for its efforts in promoting computer literacy among the youth and general public of the district. The New Digital Computer focuses on providing comprehensive computer education and training programs. These programs are designed to cater to various levels of learners, from beginners to advanced users, ensuring that a wide demographic can enhance their digital skills. The institution's courses often cover fundamental computer operations, advanced software applications, and other essential digital literacy topics.

Both parties have been working on propagating the computer and digital literacy among the student of Nalbari College, and general mass of people. The MoU will boost the collaborative effort to many folds in near future.

Department of Nalbari College, Nalbari and New Digital Computer, Nalbari, hereinafter collectively referred to as the parties/institutions, and individually as party/institution.

#### **Objectives**

- 1. Incorporate practical, hands-on training for digital literacy among the students of Nalbari College.
- 2. Collaborate on updating and enhancing the curriculum to include digital literacy in the course curriculum.
- 3. Facilitate computer literacy training programsamong the students.

There will be no financial obligations on both parties under this agreement.

### **General Coordinators:**

Each party shall designate an administrative office/department to oversee and facilitate the implementation of any agreements arising out of this MoU.

#### **Intellectual Property Rights:**

Nalbari College, Nalbari and New Digital Computer, Nalbari agree to respect each other's right to intellectual property. Further, all rights linked to ideas, inventions, and patents generated during the MoU shall remain the common intellectual property of the parties. The parties shall not pass on or give usage rights of such property to any third party without the consent of the other party.

# **Dispute Settlement:**

In the event of any dispute or differences arising under this agreement, the parties shall try to discuss and arrive at an amicable resolution thereof. If the parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute having arisen, the matter shall be referred to arbitration by a single arbitrator appointed under the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be held in Guwahati and the language of arbitration shall be English. The parties agree that the decision of the arbitrator shall be final and binding on the parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

This MoU shall be constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create a legal relationship between the parties.

This MoU shall come into force from the date of its signatures and shall remain valid for 05 years. This MoU may be modified/renewed, or extended with the mutual written consent of the parties.
