This memorandum of understanding is made and executed on 2/2/23 for 05 years from 2/2/23 to 1/2/28 between the Nalbari college, P.O. Nalbari, Dist. Nalbari, Assam, India, PIN - 781335 and the Xipa, Nalbari, Dist. - Nalbari, Assam, India, PIN - 781335.

Preamble

Nalbari College, Nalbari is one of the premier higher educational institutions in Assam. The institution is established in pre-independent India on 4th July 1945. From its establishment onwards, the college has taken a pioneering role in shaping and promoting higher education in the entire lower Brahmaputra valley. This is one of the premier colleges that consistently demonstrated excellence in academic and research pursuits.

Xipa, Nalbari is a prominent Art and drama organization in the Nalbari District, established in 2008. Since its inception, the organization has been dedicated to promoting art and drama activities among the youth and general people of the region and playing a crucial role in nurturing, and developing local talent.

Nalbari College, Nalbari, and Xipa, Nalbari, a renowned cultural organization in Nalbari, have collaborated to promote art and drama activities among the students. This partnership aims to enhance the artistic and dramatic skills of students, fostering greater participation and appreciation for the arts.

Nalbari College, Nalbari, and Xipa, Nalbari, hereinafter collectively referred to as the parties/institutions, and individually as party/institution.

Objectives

The objective of the Memorandum of Understanding (MoU) between Nalbari College and Xipa, Nalbari focuses on several key goals:


1. To Organize workshops and training sessions led by experienced artists and dramatists to help students hone their skills in various forms of art and drama.
2. Facilitating cultural exchange programs where students can interact with established artists, learn from their experiences, and gain new perspectives on art and drama.


There will be no financial obligations on both parties under this agreement.

Each party shall designate an administrative office/department to oversee and facilitate the implementation of any agreements arising out of this MoU.

Intellectual Property Rights:

Nalbari College, Nalbari and Xipa, Nalbari agree to respect each other's right to intellectual property. Further, all rights linked to ideas, inventions, and patents generated during the MoU shall remain the common intellectual property of the parties. The parties shall not pass on or give usage rights of such property to any third party without the consent of the other party.

Dispute Settlement:

In the event of any dispute or differences arising under this agreement, the parties shall try to discuss and arrive at an amicable resolution thereof. If the parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute having arisen, the matter shall be referred to arbitration by a single arbitrator appointed under the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be held in Guwahati and the language of arbitration shall be English. The parties agree that the decision of the arbitrator shall be final and binding on the parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

This MoU shall be constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create a legal relationship between the parties.

This MoU shall come into force from the date of its signatures and shall remain valid for 05 years. This MoU may be modified/ renewed, or extended with the mutual written consent of the parties.
