This memorandum of understanding is made and executed on 24,06,19 for 05 years from 24,06,19... to 23,06,24.... between the Nalbari college, P.O. Nalbari, Dist. Nalbari, Assam, India, PIN - 781335 and the Mugkuchi Gaon Panchayat, Dist. – Nalbari, Assam, India, PIN - 781334.

Preamble

Nalbari College, Nalbari is one of the premier higher educational institutions in Assam. The institution is established in pre-independent India on 4th July 1945. From its establishment onwards, the college has taken a pioneering role in shaping and promoting higher education in the entire lower Brahmaputra valley. This is one of the premier colleges that consistently demonstrated excellence in academic and research pursuits.

Mugkuchi is a census village in Nalbari district, Assam, India. As per the 2011 Census of India, Mugkuchi village has a total population of 2,423 people including 1,240 males and 1,183 females with a literacy rate of 80.07%. Mugkuchi village is known for Jaapi artisans. This is an adapted village of Nalbari College.

The collaborative efforts between Nalbari College and the village community have been instrumental in driving community development initiatives and enhancing education in the village. By developing both online and offline teaching frameworks tailored for school students, Nalbari College aims to inspire and motivate them to pursue higher education.

This partnership not only focuses on improving educational opportunities but also actively engages in community development pursuits within the village. Through various educational programs and initiatives, the collaboration seeks to uplift the socio-economic status of the community while fostering a culture of learning and academic excellence among its residents.

Nalbari College, Nalbari, and Mugkuchi Gaon Panchayat, Nalbari hereinafter collectively referred to as the parties/institutions, and individually as party/institution.

Objectives

The objective of the Memorandum of Understanding (MoU) between Nalbari College and its adopted village focuses on several key goals:

 Enhancing Education: To provide a strong foundation for higher education and scientific learning among high school students in the region.

- Developing Teaching Frameworks: To establish both online and offline teaching frameworks tailored for high school students, enhancing their learning experience and accessibility to quality education.
- Career Development and Guidance: To offer comprehensive information and guidance to high school students regarding career development and placement opportunities.
- Community Engagement: To foster a collaborative relationship between Nalbari College and the adopted village, promoting community development through educational initiatives.
- 5. Motivating Higher Education: To inspire and encourage students to pursue higher education by providing the necessary resources, support, and motivation.

There will be no financial obligations on both parties under this agreement.

General Coordinators:

Each party shall designate an administrative office/department to oversee and facilitate the implementation of any agreements arising out of this MoU.

Intellectual Property Rights:

Nalbari College, Nalbari and Mugkuchi Gaon Panchayat, Nalbari agree to respect each other's right to intellectual property. Further, all rights linked to ideas, inventions, and patents generated during the MoU shall remain the common intellectual property of the parties. The parties shall not pass on or give usage rights of such property to any third party without the consent of the other party.

Dispute Settlement:

In the event of any dispute or differences arising under this agreement, the parties shall try to discuss and arrive at an amicable resolution thereof. If the parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute having arisen, the matter shall be referred to arbitration by a single arbitrator appointed under the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be held in Guwahati and the language of arbitration shall be English. The parties agree that the decision of the arbitrator shall be final and binding on the parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

This MoU shall be constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create a legal relationship between the parties.

This MoU shall come into force from the date of its signatures and shall remain valid for 05 years. This MoU may be modified/ renewed, or extended with the mutual written consent of the parties.
