This memorandum of understanding is made and executed on 19,09,22. for 05 years from 19,19,22.... to 18,19,27.... between the Nalbari college, P.O. Nalbari, Dist. Nalbari, Assam, India, PIN - 781335 and the Kamrup Vidyapeeth High School, Vill - Mugkuchi, Dist. Nalbari Assam, India, PIN - 781334.

Preamble

Nalbari College, Nalbari is one of the premier higher educational institutions in Assam. The institution is established in pre-independent India on 4th July 1945. From its establishment onwards, the college has taken a pioneering role in shaping and promoting higher education in the entire lower Brahmaputra valley. This is one of the premier colleges that consistently demonstrated excellence in academic and research pursuits.

Kamrup Vidyapeeth High School, located in Mugkuchi Gaon, Nalbari, is a renowned educational institution in the Nalbari District. Since its establishment in 1978, the school has been committed to providing quality education to high school students. Situated in the adopted village of Nalbari College, Kamrup Vidyapeeth High School has played a significant role in the academic development of the region, maintaining a tradition of excellence in education for over four decades.

Both parties have been actively working towards enhancing education in the region. In collaboration, Nalbari College will develop both online and offline teaching frameworks for high school students, aiming to motivate them towards pursuing higher education. This partnership seeks to improve educational opportunities and outcomes for students in the region.

This partnership not only focuses on improving educational opportunities but also actively engages in community development pursuits within the village. Through various educational programs and initiatives, the collaboration seeks to uplift the socio-economic status of the community while fostering a culture of learning and academic excellence among its residents.

Nalbari College, Nalbari, and Kamrup Vidyapeeth High School hereinafter collectively referred to as the parties/institutions, and individually as party/institution.

Objectives

The broad objective of the agreement is to provide a foundation for higher education and scientific learning among high school students in the region. This includes offering



information and guidance for career development and placement, thereby enhancing educational opportunities and outcomes for the students.

There will be no financial obligations on both parties under this agreement.

General Coordinators:

Each party shall designate an administrative office/department to oversee and facilitate the implementation of any agreements arising out of this MoU.

Intellectual Property Rights:

Nalbari College, NalbariandKamrup Vidyapeeth High School, Nalbari agree to respect each other's right to intellectual property. Further, all rights linked to ideas, inventions, and patents generated during the MoU shall remain the common intellectual property of the parties. The parties shall not pass on or give usage rights of such property to any third party without the consent of the other party.

Dispute Settlement:

In the event of any dispute or differences arising under this agreement, the parties shall try to discuss and arrive at an amicable resolution thereof. If the parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute having arisen, the matter shall be referred to arbitration by a single arbitrator appointed under the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be held in Guwahati and the language of arbitration shall be English. The parties agree that the decision of the arbitrator shall be final and binding on the parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

This MoU shall be constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create a legal relationship between the parties.

This MoU shall come into force from the date of its signatures and shall remain valid for 05 years. This MoU may be modified/ renewed, or extended with the mutual written consent of the parties.

Done at Nalbari College, Nalbari in this English language, one for each party in two originals in English.
