The institution is widely recognized for its efforts in promoting GIS Education among the youth and Professionals of the state. The GRAB GEOTECH (OPC) PVT LTD. focuses on providing comprehensive education and training programs on Geographical Information Systems(GIS). The institution's courses cover fundamental GIS operations, advanced software applications, and other essential Spatial analysis tools.

Both parties have been working on propagating the GIS training among the student of Nalbari College, and Professionals and academicians. The MoU will boost the collaborative effort to many folds in near future.

Objectives

There will be no financial obligations on both parties under this agreement.

General Coordinators:

Each party shall designate an administrative office/department to oversee and facilitate the implementation of any agreements arising out of this MoU.

Intellectual Property Rights:

Nalbari College, Nalbari and GRAB GEOTECH(OPC) PVT LTD., AMBARI, GUWAHATI agree to respect each other's right to intellectual property. Further, all rights linked to ideas, inventions, and patents generated during the MoU shall remain the common intellectual property of the parties. The parties

shall not pass on or give usage rights of such property to any third party without the consent of the other party.

Dispute Settlement:

In the event of any dispute or differences arising under this agreement, the parties shall try to discuss and arrive at an amicable resolution thereof. If the parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute having arisen, the matter shall be referred to arbitration by a single arbitrator appointed under the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be held in Guwahati and the language of arbitration shall be English. The parties agree that the decision of the arbitrator shall be final and binding on the parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

This MoU shall be constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create a legal relationship between the parties.

This MoU shall come into force from the date of its signatures and shall remain valid for 05 years. This MoU may be modified/renewed, or extended with the mutual written consent of the parties.
