

## Memorandum of Understanding

This memorandum of understanding is made and executed on 19-04-23 for 05 years from 19-04-23 to 18-04-28 between the Nalbari College, P.O. Nalbari, Dist. Nalbari, Assam, India, PIN - 781335 and the Abhiruchi Mushroom Farm and Processing Centre, Dist. - Nalbari, Assam, India, PIN - 781334.

### Preamble

Nalbari College, Nalbari is one of the premier higher educational institutions in Assam. The institution is established in pre-independent India on 4<sup>th</sup> July 1945. From its establishment onwards, the college has taken a pioneering role in shaping and promoting higher education in the entire lower Brahmaputra valley. This is one of the premier colleges that consistently demonstrated excellence in academic, research, and skill development pursuits.

Abhiruchi Mushroom Farm and Processing Centre, Nalbari is a prominent small-scale industry within the city, doing extremely good in mushroom farming and food processing of the fermented food products. Since its inception in 2000, the farm has been dedicated to promoting mushroom cultivation among the unemployed youth across the state Assam.

Nalbari College, Nalbari and Abhiruchi Mushroom Farm and Processing Centre, Nalbari have joined forces to promote mushroom cultivation and food processing among the students of Nalbari College. This collaborative effort aims to enhance the possibilities of self-employability among the youth.

Nalbari College, Nalbari, and Abhiruchi Mushroom Farm and Processing Centre, Nalbari hereinafter collectively referred to as the parties/institutions, and individually as party/institution.

### Objectives

The objective of the Memorandum of Understanding (MoU) between Nalbari College, Nalbari and Abhiruchi Mushroom Farm and Processing Centre, Nalbari focuses on several key goals:

1. To facilitate hands-on training and practical experience for students in the field of mushroom cultivation and processing.
2. To develop innovative solutions to enhance productivity and sustainability in mushroom farming.

3. To provide skill development programs and workshops for students and local farmers to enhance their knowledge and expertise in mushroom cultivation.
4. To organize community outreach programs and awareness campaigns about the benefits of mushroom farming.

There will be no financial obligations on both parties under this agreement.

#### **General Coordinators:**

Each party shall designate an administrative office/department to oversee and facilitate the implementation of any agreements arising out of this MoU.

#### **Intellectual Property Rights:**

Nalbari College, Nalbari and Abhiruchi Mushroom Farm and Processing Centre, Nalbari agree to respect each other's right to intellectual property. Further, all rights linked to ideas, inventions, and patents generated during the MoU shall remain the common intellectual property of the parties. The parties shall not pass on or give usage rights of such property to any third party without the consent of the other party.

#### **Dispute Settlement:**

In the event of any dispute or differences arising under this agreement, the parties shall try to discuss and arrive at an amicable resolution thereof. If the parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute having arisen, the matter shall be referred to arbitration by a single arbitrator appointed under the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be held in Guwahati and the language of arbitration shall be English. The parties agree that the decision of the arbitrator shall be final and binding on the parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

This MoU shall be constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create a legal relationship between the parties.


This MoU shall come into force from the date of its signatures and shall remain valid for 05 years. This MoU may be modified/ renewed, or extended with the mutual written consent of the parties.
