Nalbari College has consistently demonstrated excellence in art and culture along with academic pursuits. The Seema Biswas Centre for Films and Performing Arts, Dept. of English was established in 2017 to inculcate interest in students in the field drama.

SUNAG is a cultural organization established in 1998 at Kaithalkuchi, Nalbari. It promotes activities in the field of drama in the midst of a natural setting. As a part of the activities in the field of drama, "Patharnaatmala" is held annually in Kaithalkuchi by SUNAG during the month of February/March in a natural setting. Here various dramas are staged by local artists and from artists across the state. The organization has played an important role in motivating and promoting young minds in the field of drama.

This partnership between the Seema Biswas Centre for Films and Performing Arts, Dept. of English, Nalbari College and SUNAG aim to enhance dramatic skills among the students and also fostering in them greater participation and appreciation for drama.

Seema Biswas Centre for Films and Performing Arts, Dept. of English, Nalbari College, Nalbari, and SUNAG are collectively referred to as the parties/institutions, and individually as party/institution.

## **Objectives**

The objective of the Memorandum of Understanding (MoU) between Seema Biswas Centre for Films and Performing Arts, Dept. of English, Nalbari College, Nalbari, and SUNAG focuses on several key goals:

- 1. To make students hone their skills in the art of drama by making them play an active role in the annual dramatic activities.
- Facilitating students to participate in the annual activities and also interact with artists both local and across the state so that they can learn from their skills and experiences, and gain new perspectives on art and drama.

There will be no financial obligations on both parties under this agreement.

#### **General Coordinators:**

Each party shall designate an administrative office/department to oversee and facilitate the implementation of any agreements arising out of this MoU.

# **Intellectual Property Rights:**

Seema Biswas Centre for Films and Performing Arts, Dept. of English, Nalbari College, Nalbari, and SUNAG agree to respect each other's right to intellectual property. Further, all rights linked to ideas, inventions, and patents generated during the MoU shall remain the common intellectual property of the parties. The parties shall not pass on or give usage rights of such property to any third party without the consent of the other party.

### **Dispute Settlement:**

In the event of any dispute or differences arising under this agreement, the parties shall try to discuss and arrive at an amicable resolution thereof. If the parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute having arisen, the matter shall be referred to arbitration by a single arbitrator appointed under the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be held in Guwahati and the language of arbitration shall be English. The parties agree that the decision of the arbitrator shall be final and binding on the parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

This MoU shall be constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create a legal relationship between the parties.

This MoU shall come into force from the date of its signatures and shall remain valid for 05 years. This MoU may be modified/renewed, or extended with the mutual written consent of the parties.
