This memorandum of understanding is made and executed on 28-03-23 for 05 years from 28-2-23. to 37-2-238. between the Nalbari college, P.O. Nalbari, Dist. Nalbari, Assam, India, PIN - 781335 and the MNC Balika Vidyapeeth, Nalbari, Assam, India, PIN - 781335.

Preamble

Nalbari College, Nalbari is one of the premier higher educational institutions in Assam. The institution is established in pre-independent India on 4th July 1945. From its establishment onwards, the college has taken a pioneering role in shaping and promoting higher education in the entire lower Brahmaputra valley. The Department of Botany is one of the oldest departments of the institute. This is one of the premier departments of the college that consistently demonstrated excellence in academic and research pursuits.

MNC Balika Vidyapeeth is one of the premier girls' high schools in Nalbari, Assam established in 1973. Since its inception, the school has been dedicated to promoting girls' education in the lower Brahmaputra valley.

Both parties have been actively working towards enhancing education in the region. In collaboration, Nalbari College will develop both online and offline teaching frameworks for high school students, aiming to motivate them towards pursuing higher education. This partnership seeks to improve educational opportunities and outcomes for students in the region.

Nalbari College, Nalbari, and MNC Balika Vidyapeeth, Nalbari hereinafter collectively referred to as the parties/institutions, and individually as party/institution.

Objectives

The broad objective of the agreement is to provide a foundation for higher education and scientific learning among high school students in the region. This includes offering

information and guidance for career development and placement, thereby enhancing educational opportunities and outcomes for the students.

There will be no financial obligations on both parties under this agreement.

General Coordinators:

Each party shall designate an administrative office/department to oversee and facilitate the implementation of any agreements arising out of this MoU.

Intellectual Property Rights:

Nalbari College, Nalbari and MNC Balika Vidyapeeth, Nalbari agree to respect each other's right to intellectual property. Further, all rights linked to ideas, inventions, and patents generated during the MoU shall remain the common intellectual property of the parties. The parties shall not pass on or give usage rights of such property to any third party without the consent of the other party.

Dispute Settlement:

In the event of any dispute or differences arising under this agreement, the parties shall try to discuss and arrive at an amicable resolution thereof. If the parties fail to arrive at an amicable resolution within (thirty) 30 days of the dispute having arisen, the matter shall be referred to arbitration by a single arbitrator appointed under the Arbitration and Conciliation Act, 1996. The arbitral proceedings shall be held in Guwahati and the language of arbitration shall be English. The parties agree that the decision of the arbitrator shall be final and binding on the parties. The arbitration tribunal shall also decide on the costs of the arbitration procedure.

This MoU shall be constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall be constructed to create a legal relationship between the parties.





This MoU shall come into force from the date of its signatures and shall remain valid for 05 years. This MoU may be modified/ renewed, or extended with the mutual written consent of the parties.
