Important Instructions for the Candidates

1. Spot admission will be held as per the scheduled dates and guidelines notified by Office of the Director of Higher Education, Government of Assam.
2. All students willing to get admitted in College are to report at 10:00 AM on 15.06.2026 with all the relevant documents.
3. There will be no selection list for spot admission. Admission will be on **First Come First Chance** basis.
4. Spot admission of subsequent days will be held depending on the vacancies/cancellations after the admission held on previous day
5. Admission of applicants in Spot Round: **15 June 2026 to 17 June 2026 (Except Sunday)**
6. The Applicants who wish to take Admission must register in the **College Portal** (<https://nalbaricollege.co.in/>)
7. **Admission will be granted only after verification of relevant documents and fulfillment of the prescribed eligibility criteria.**
8. Admissions will be conducted strictly in accordance with Government rules and regulations.
9. Candidates must bring the following documents **in original** along with **one set of self-attested photocopies**:
 - a. Printed copy of the **SAMARTH & College Portal** online application form
 - b. Original and photocopy of mark sheet of Class XII.
 - c. Caste certificate (wherever applicable) (Reservation benefits will be provided as per the Government of Assam policy.)
 - d. PwD certificate (wherever applicable)
 - e. Extracurricular certificate (wherever applicable)
 - f. Anti Ragging Declaration Form. (Available in College Website: nalbaricollege.ac.in)
 - g. Affidavit/Gap Certificate for those Students who seeking admission in **Gap Period**.


Instructions for Availing Fee Waiver Scheme

1. The fee waiver scheme is not applicable for self financing course.
2. Students must produce any one of the following original documents and submit a photocopy as proof of domicile in Assam:
 - PRC
 - Voter Id Card
 - AADHAR Card
 - Passport
 - Birth Certificate
3. They have to submit a ration card issued by the competent authority as a proof that his/her parental income is less than Rs.4.0 lakh annually from all sources.
4. Candidates must submit a declaration stating that neither parent is employed under the State/Central Government or any Government Undertaking. (Available in College Website: nalbaricollege.ac.in)

NOTIFICATION

This is in continuation of UG admission 2026 timelines and guidelines issued vide letter no: 75718/10 dated 6th May, 2026, that Spot admissions for UG 2026 will be conducted from 15th to 17th June, 2026 by the participating Higher Educational Institutions in the Assam State Higher Education Admission Portal against the Institution-wise (discipline-wise/ programme-wise) vacancies published in the admission portal.

In this regard, the undersigned is pleased to notify the following points:

1. Mandatory Registration on the Admission Portal for Spot admissions

Participation in the Spot Admission process shall be subject to the applicant being duly registered on the Assam State Higher Education Admission Portal. In this regard, the following shall apply:

- Applicants who have already registered on the admission portal and possess a valid Registration Number are not required to register again.
- Applicants who have not yet registered on the admission portal may do so from 13th June onwards till 17th June, 2026 (4 P.M), prior to participating in the Spot Admission process.

2. Institution-Specific Spot Admission Policy

- Participating Higher Educational Institutions may formulate and adopt institution-specific policies for the conduct of Spot Admissions, provided that such policies are consistent with the overarching principles in regard to admission.
- All institution-specific Spot Admission policies, along with detailed procedures and guidelines, shall be mandatorily published on the respective institutional websites on or before 13th June, 2026, to ensure adequate notice to prospective applicants.
- Institutions are advised to ensure that the published guidelines are comprehensive, unambiguous, and accessible, enabling applicants to make informed decisions about their participation in the Spot Admission process.

All Heads of the participating Institutions are requested to kindly follow the above-mentioned points in the larger interest of the applicants and to comply with the Government mandate of ensuring a seamless and transparent admission process.
